With our letter to you of December 23, 2003, Kirby Inland Marine, LP ("Kirby") advised that all vessels owned and/or operated by Kirby which are subject to the requirements of 33 CFR Part 104 will operate under the American Waterways Operators Alternative Security Program for Tugboats, Towboats and Barges dated October 31, 2007, and approved in 33 CFR 101.125(b), which Program will be implemented in its entirety.

To our December 23, 2003 letter was attached a Schedule of Vessels as of the date of that letter, and we advised you that vessels are frequently added to or deleted from our fleet. The following vessels should be added/deleted/name changed, as indicated, to that Schedule:


