The maximum design density of cargo which may be filled to the tank top is 9.99 lbs/gal. Cargoes with higher densities, up to 13.57 lbs/gal, may be carried as slack loads, but shall not exceed the tank weight limits as listed above.

Per 46 CFR 151.10-15(c)(2) the max tank weight reflect uniform (within 5%) loading at the deepest draft allowed. When carrying Subchapter O cargoes at shallower drafts, the barge(s) should always be loaded uniformly.

In accordance with 46 CFR Part 39, excluding part 34.4000, this vessel's vapor collection system (VCS) has been inspected to the plans approved by MSC Letter # C1-1000416 dated February 19, 2010 and has been found acceptable for the collection of bulk liquid cargo vapors annotated with "Yes" in the CAA's VCS column. The VCS has been approved with a pressure side of 6 psig P/V valve with Coast Guard Approval 162.017/167/2. The cargo tank top is suitable for a maximum allowable working pressure (MAWP) of 6.5 psig.
