When the vessel is carrying cargoes containing greater than 0.5% benzene, the person in charge is responsible for ensuring the provisions of 46 CFR 197, Subpart C, are applied

Per 46 CFR 150.130, the Person In Charge of the vessel is responsible for ensuring that the compatibility requirements of 46 CFR 150 are met. The maximum design density of cargo which may be filled to the tank top is 9.99 lbs/gal. In Accordance with 46 CFR Part 39, excluding part 39.4000, this vessel's vapor collection system (VCS) has been inspected to the plans approved by Marine Safety Center letter Serial No. C1-1303374 dated October 18, 2013, and has been found acceptable for the collection of bulk liquid cargo vapors annotated with "Yes" in the CAA's VCS column. The VCS system has been approved with a pressure side of 6 psig P/V valve with Coast Guard Approval 162.017/167/4. The cargo tank top is suitable for a maximum allowable working pressure (MAWP) of 6.50 psig.
