In accordance with 46 CFR 39, excluding part 39.4000, this vessel's vapor control system (VCS) has been inspected to the plans approved by MSC letter Serial # C1-1200902 dated February 15, 2012, and has been found acceptable for collection of bulk liquid cargo vapors annotated with "yes" in the CAA's VCS column. The VCS system has been approved with a pressure side of 6 psig P/V valve with Coast Guard Approval 162.017/0000167/3. The cargo tank top is suitable for a maximum allowable working pressure (MAWP) of 6.5 psig.

In accordance with 46 CFR part 39.1017 and 39.5001(e) this vessel's VCS has been evaluated and approved for multi-breasted tandem loading with this vessel.
