In accordance with 46 CFR 39, excluding part 39.4000, this vessel's vapor collection system (VCS) has been inspected to the plans approved by MSC Letter #C1-1202871 dated 06JUN2012 and has been found acceptable for the collection of bulk liquid cargo vapors annotated with "Yes" in the CAA's VCS column. The VCS system has been approved with a pressure side of 1.5 psig P/V valve with Coast Guard Approval 162.017/167/3. The cargo tank top is suitable for a maximum allowable working pressure (MAWP) of 3.00 psig.

In accordance with 46 CFR Part 39.5000, this vessel's VCS has been evaluated and approved for multi-breasted tandem loading with other vessels specifically approved by Marine Safety Center letter Serial No. C1-1602921 dated 10AUG2016.
